SPEAKERS



NATASHA WEBSTER is a researcher in human geography, with research focusing on feminist economic geography. Her current project explores the role of women-led entrepreneurship in migration and integration, while previous projects have focused on migration, gender, translocalism and rural areas with a focus on Thai migrant women in Sweden.



ANNA SANDER and **JOSEPHINE APPELQVIST** are founders and directors of TALITA with over 20 years of experience working with women exploited in prostitution, pornography and human trafficking for sexual purposes. Prior to founding Talita in 2004, Anna and Josephine were part of an outreach group providing emotional and practical support to prostitutes. Anna is a trauma therapist, licensed pharmacist and has several years' experience in professional development and training for educational institutions while Josephine is a trauma therapist and has a background in law, with earlier experience working in the fight against the sexual exploitation of children.



JEANNE MASIMANGO MANDUMA is the chairperson of the women's organization ASOV Stockholm and in charge of migrants at Swedish NGO Noaks Ark. Before her current posts, Jeanne worked at RFSU Stockholm as project manager. Jeanne has been involved in establishing a number of organizations such as ASOV Stockholm, the National Association for Young ASOV, JM education and the Foundation for Jeanne Manduma in RD Congo and Burundi. Jeanne Masimango Manduma was born in RD Congo and came to Sweden through an arranged marriage. She is currently working on a documentary film.



LOUISA VOGIAZIDES is a PhD researcher in human geography and works on a project on residential mobility, integration and segregation among international migrants in Sweden, with a focus on differences in mobility patterns between ethnic and social groups. In previous projects she examined trafficking for forced labour and labour exploitation, and social remittances.



KAREN HAANDRIKMAN is a senior lecturer in population geography in the fields of migration, integration and segregation. Current projects focus on migrant women entrepreneurship, migrant trajectories, contextual effects on intergenerational mobility and labour market outcomes, and socioeconomic segregation in Europe.
